During his almost 18 years long career at ING Group, he held various Senior Management positions, amongst others, Chief Actuary of ING Insurance, Belgium and ING South West Europe as well as Chief Risk Officer ("CRO") of ING Retail Banking and ING Central Europe. In January 2011, he joined Ageas Group as a Group Risk Officer and member of Management Committee of Ageas Group. Subsequently on 1 June 2019, he was appointed as an Executive Director, CRO and member of Executive Committee of Ageas Group.

Mr. Van Grimbergen was the Non-Executive Director of Cardif Lux Vie, Belgium (a subsidiary of BNP Paribas Group) and Intreas N.V. (a captive reinsurer of Ageas Group). He was also a former Chairman of the CRO Forum Association, Netherlands. He is currently a member of De Warande Club, Belgium.

Besides the Maybank Group, Mr. Van Grimbergen currently sits on the boards of Non-Executive Director ("NED") of Ageas Insurance International N.V. and Royal Park Investments SA/NV, Belgium.
